- Any other aspect relevant to the assessment.

We strongly encourage you to participate and to submit any comment or complaint regarding this company. Your comment/complaint must include the following information:

- i. name of project,
- ii. your relationship with the project,
- iii. comment/complaint and its relevance,
- iv. Evidence material (as attachments).

Internally, your comments will be duly evaluated by the audit team. Only if the comment/complaint is considered relevant by the audit team and/or by the RTRS technical unit personnel, such comment/complaint will be communicated with the applicant. The author of such comment/complaint will be notified about the evaluation outcome within 3 months after the date when the certification decision is taken.

After the closing meeting, a report of the certification assessment will be of public domain on the Control Union Certifications and RTRS websites, including a summary of the public consultation process.

In case the outcome is not of your satisfaction, we invite you to follow the dispute resolution procedure of Associação Control Union Certificates. You can directly get the Dispute Resolution Protocol on our website (Article 15 and Annex B of ACUC Inspection Regulation/Annex 16 PM). Our staff can provide you any advice on it and/or can send you the appropriate documents on your request. You can also contact the RTRS technical unit directly.
